New shuffle board courts, bocce ball courts, horseshoe pits, gas grill, and fire pit are all installed and ready for use.

Fence – A new white vinyl fence will be replacing all the wooden fencing. Waiting on permits from the county. Material has been delivered.

April rent must be paid to the office by check or money order during the transition to the new management group. May rent may be done by automatic withdrawal.

Management interviewing candidates for assistant manager position.
