LADIES LUNCHEON - MAY

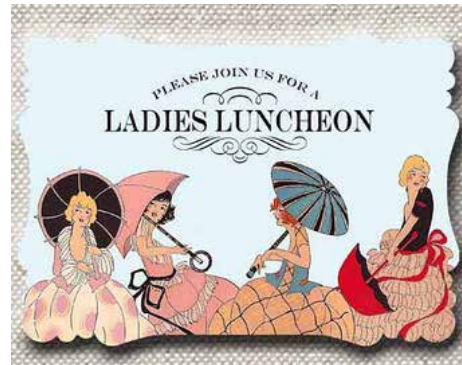
