At least ninety (90) days prior to the January Annual Meeting, the President shall select a Chairperson for the Nominating Committee. The Committee shall consist of the Chairperson, one (1) Director, and three (3) other members selected by the Chairperson.

The board had a discussion of questions that they would like answered at the meeting with the new proposed

President Ken Hamlin opened the meeting at 10:40 a.m. by Skype. Officers present: President Ken Hamlin, Vice President Anne Lennon, Treasurer Bob Green, and Secretary Gloria Emery. Directors present: Ruth Brooks, Cheryl Wellence, Joe Glasgow and Chris Bennett. Guests present: Leo Wellence, Cheryl Schrack, Carl Glass, Joan Bollinger, Jo Hilliker, Mary Glasgow, Joan Cromeenes, Charlotte Read, Jan Wingard, Donna Robichaud, Diane Peake and Rosalyn Green.

Purpose of the meeting is to discuss the sale of Lakewood Village and the possibility of the residents purchasing the park.

Bob Green explained in great detail hypothetical financial situations if a purchase could be accomplished and a loan could be obtained. The purchase price would be \$24,250,000 with a total down payment of \$4,850,000 which is 20% of the purchase price. Copy of worksheet attached to these minutes.

Motion by Joe Glasgow that it is not a feasible investment for the HOA at this time based on the figures presented and that the board should not pursue any further. Cheryl Wellence supported. Motion voted on was unanimous by all board members present.

Motion by Bob Green to authorize Ken Hamlin and Gloria Emery to sign the "Agreement Waiving Rights Granted by Section 723.071, Florida Statues." Supported by Joe Glasgow. Motion unanimous by all board members present.

Motion by Joe Glasgow to add Diane Peake, Dean Helsom and Robert Lekich to the Rent Negotiating Committee with Ruth Brooks as chairman. Supported by Chris Bennett. Motion unanimous.





#### **DAYLIGHT SAVINGS TIME ENDS**

If you are asking, "When does Daylights Savings time end in 2018 in the U.S.A.?" The answer is the date that Daylight Savings Time (DST) will end for Florida is at 2 a.m. on Sunday, November 4, 2018.

Daylight Savings Time 2018 ends after Halloween when nights become longer and longer in the northern hemisphere as the calendar nears the Winter Solstice.

The rest of the United States will also turn their clocks back on November 4, 2018 except for Hawaii and Arizona because those states do not practice Daylight Savings Time.

Florida Governor Rick Scott signed a bill into law in March to put an end to the practice of setting clocks back and forward every six months. But Florida still must wait for the U.S. Congress to approve an exemption to remain on Daylight Saving Time throughout the year.

This means that we gain (not lose) an hour when we turn our clocks back an hour to 1:00 a.m. when our clocks reach 2:00 a.m. on Sunday, November 4.



A helpful way to remember whether to set our clocks ahead or behind one hour during the Daylight-Saving Time change for Fall 2018 is to "Fall Back" and "Spring Ahead."

Daylight Saving Time will begin again on Sunday, March 10, 2019.




#### **VETERANS DAY 2018**

As a federal holiday Veterans Day is typically observed on November 11th every year. However, if it occurs on a Sunday then the following Monday is designated as the Federal holiday, and if it occurs on a Saturday then either Saturday or Friday may be designated.

#### FLORIDA NON-HOMESTEAD TAX

Your homeowner's association normally does not get involved in political issues. However, some residents have indicated their concern regarding the Florida Non-Homestead amendment appearing on the November ballot. It possibly could influence future property taxes including the taxes as related to Lakewood Village. We take no action either way, just letting you know it will be on the ballot when you vote for those registered to vote in Florida.

The amendment is as follows.

Florida Amendment 2, the Permanent Cap on Non-homestead Parcel Assessment Increases Amendment, is on the ballot in Florida as an amendment on November 6, 2018.

A "yes" vote supports this amendment to make permanent the cap of 10 percent on annual non-homestead parcel assessment increases set to expire on January 1, 2019.

A "no" vote opposes this amendment to make permanent the cap of 10 percent on annual non-homestead parcel assessment increases set to expire on January 1, 2019.




