Missing Children's Citizen Award

JUSTICE DEPARTMENT HONORS FLORIDA BUS DRIVER FOR RETURN OF MISSING CHILD

The Department of Justice today presented Ms. JoAnn Donovan with the Missing Children's Citizen Award. Ms. Donovan, a school bus driver from Punta Gorda, Florida, helped locate a 15-year-old girl with special needs who was reported missing when she did not board the bus at her foster home. This award honors the extraordinary efforts of private citizens for their unselfish acts to recover missing or abducted children safely, and comes during the 37th annual commemoration of National Missing Children's Day.

In an interview with the officers investigating the case of the missing child, Ms. Donovan reported that the girl had recently been talking on her cell phone with her biological mother, from whose custody she had been removed. A tip yielded a video camera picture taken of the child and her mother in a car passing through a tollbooth in another state. Police returned the girl to her foster family unharmed just one day after she went missing. Her mother will spend two years in jail.

"The compassion and loyalty that Ms. Donovan encompasses demonstrate the positive impact that ordinary citizens can have on the lives of those around them," said Katharine T. Sullivan, Principal Deputy Assistant Attorney General for the Office of Justice Programs. "The Department of Justice applauds her efforts, along with those of the law enforcement officials who searched for the girl and brought her home safely."

"Ms. Donovan's dedication to and awareness of the children she transports made all the difference in this case," said Office of Juvenile Justice and Delinquency Prevention Administrator Caren Harp. "We would like to congratulate her and the officers involved for quickly finding and returning this child to her foster family."

The department also recognized nine law enforcement officers from Wisconsin, Louisiana, and Florida for their efforts to find missing children and bring child

sexual predators and child pornographers to justice. The department declared Elliana Conrad, a fifth-grader at the Antonia Crater Elementary School in Newberg, Oregon, winner of the 2020 National Missing Children's Day poster contest.

Due to restrictions resulting from COVID-19, the in-person ceremony to honor the recipients has been canceled. Instead, this website features information about the awardees and statements from Office of Justice Programs Principal Deputy Assistant Attorney General Katharine T. Sullivan and Office of Juvenile Justice and Delinquency Prevention Administrator Caren Harp.

The Office of Justice Programs, directed by Principal Deputy Assistant Attorney General Katharine T. Sullivan, provides federal leadership, grants and resources to improve the nation's capacity to prevent and reduce crime, assist victims and enhance the rule of law by strengthening the criminal and juvenile justice systems. HOMETOWN MEMORIES

Grandma and Grandpa's House

When I was just a kid back in the 1950's, our family spent a lot of time on weekends visiting with our paternal grandparents, who lived only about 10 miles away on the border of Dearborn and Detroit, in a community nicknamed Warrendale. Some of my friends had Italian grandparents, or maybe Irish or German, but my dad's parents were Polish. Grandpa was an immigrant who came over in the early 1900's, but grandma was born on a farm in central Texas to parents who had emigrated in the mid 1800's. I can still see my grandma standing at the stove in her tiny kitchen, dressed in her flowered Sears catalogue housedress and wearing her blue slippers. She had permed salt and pepper hair which, when it got unruly, she casually kept off her face with an ever-present bobby pin. I think she washed that hair with bar soap! That was grandma; loving and caring but very practical and down to earth.

Sometimes we would visit on Saturday at lunchtime. Grandma would have put out a platter of lunchmeat and cold cuts, and maybe some cheese and rye breads. Grandpa's favorite was the darkest black rye or pumpernickel. Sometimes we had Angel Wings, all light,

sweet and covered in powdered sugar! Occasionally grandma got a Babka, but the Polish cakes were not sweet at all and none of us kids cared for it. No frosting! The breads ...continued on page 12



and cakes most likely came from Tysar's Bakery, located just up on busy Warren Avenue and within walking distance from grandma and grandpa's house. Most all the Polish families in grandma's neighborhood shopped at Tysar's, and they usually walked, dragging a shiny metal cart along to hold all their delicious goodies. Another family favorite were the Sander's cakes that grandma bought, this time at the supermarket or a Sander's Store, for birthdays. One of the things I remember the best is when grandma let me drink "coffee;" she would take a small Welch's Jelly glass, fill it with half milk and half coffee. I thought I was so special when I got that drink, even though I really did not like it much. Kids today are missing the fun of going to the supermarket, picking out their favorite jelly and getting free Tom &Jerry drinking glasses!

Sunday dinner we sometimes had Grandma's Texas style country fried pork chops, which were my favorite, or maybe chicken, kielbasa or roast beef. The table was usually groaning from all the food piled on top! No trip to our grandparents'



house was complete without a look inside the Candy Cupboard. Occasionally, all grandma had left was Circus Peanuts, which none of us girls liked. (Our cousins must have gotten to the good stuff, darn it!)

Sometimes in summer, if we were lucky, the Good Humor Man would drive down Woodmont Street. Of course, we all got an ice cream because grandma and grandpa couldn't say no. Summer visits were best because we could sit on grandma's back porch and rock in her decorative metal patio chairs while smelling the wonderful scents of her garden roses and the honeysuckle vine that wound around the side of house. We could also see rows of lovingly planted beans, cucumbers and tomatoes, plus an apple and peach tree, all carefully planted to fit their city lot. If we happened to be playing out front in the spring, we could see the huge colorful mounds of fragrant Alyssum grandpa planted just bordering his shrubs. I remember grandpa and grandma spent a lot of time watering and caring for all their plantings. The house on Woodmont Street was the first home they had ever owned, and they took excellent care of it, inside and out. All other homes they had occupied were rented, which was not that unusual for families during and just after the depression.

Grandma and grandpa had great neighbors. Everyone was friendly and everyone looked out for each other.

But I think the main reason my grandparents lived in Warrendale was for the walkability. The local Catholic Church, St. Christopher's, was only two blocks away. Grandpa attended early



Mass every morning. After having struggled through two wars and the depression in the 30's, I think grandpa was incredibly grateful for the good life he had finally achieved. He had a secure job at Ford Motor Co., plenty to eat, a nice home and a wonderful family. Two strong sons had given him 9 grandchildren to love, and that is what I think my grandpa said a prayer of thanks for each and every day.

Grandma and grandpa are both angels now, but I think of them often and remember all the loving hugs and happy times we spent with them. It makes me smile. I hope and pray that someday my grandchild will remember me the same way.

CLUBHOUSE GRILL AND FIREPIT

It has been brought to the attention of the HOA Board that when the poolside grill is used it is not being properly maintained. The grill and firepit are intended for the use, pleasure and convenience to any and all Lakewood Village Homeowners when entertaining family, friends or neighbors. But when the grill or firepit has been used it is the user's responsibility to maintain properly. Respectfully, HOA Board.



Please read and follow the guidelines for everyone's enjoyment.

LAKEWOOD GAS GRILL GUIDELINES:

- 1. Raise grill cover
- 2. Check to make sure the grease pan is in place.
- 3. Make sure all burners are in the OFF position.
- 4. Turn on propane tank valve.
- 5. Turn on and ignite one burner at a time.
- 6. Once all burners are lit, you may close the cover to heat up the grill.
- 7. When finished grilling, clean grill and drip pan. (You need to supply a container for proper disposal of grease drippings).
- 8. Make sure all burners are in the OFF position and turn propane tank off.
- 9. Make sure grill is cleaned within 12 hours after use.
- 10. The HOA is responsible for supplying the propane.

FIRE PIT GUIDELINES:

To use Fire Pit

- 1. The key to the blue propane tank box is on the wall in the pantry marked "Fire Pit"
- 2. Check to be sure fire pit valve is OFF (the valve is on the right hand side of the pit) Vertical is on –

Horizonal is off

3. Unlock blue box, raise lid, turn on tank. Take the ignitor to pit, light the ignitor and hold over the pit and turn on the value to the vertical position.

To close Fire Pit

- 1. Turn pit valve OFF.
- 2. Make sure to return ignitor to the blue box. Check the gauge on the tank. Turn valve OFF on the tank. Close lid and lock up.
- 3. Clean up the area.
- 4. Return key to the key rack in pantry.
- 5. If tank gauge is low, contact Bill Ganier, HOA Building Chairman, 603.689.518


